

#### LIBRARY NEWS

Rocks and Minerals frequently tells me about old mines, old minerals, and things that have no relevance to me. It did it again with a center spread on Glendonites (Vol 97, Nov-Dec 2022, on the new periodical shelf in the library).

Let's start at the beginning. A clam paleontologist is visiting north of the arctic circle to look for clams of course. In addition to clams, he also finds brown crystals in the mud and he takes back a handful to his dorm and goes to bed. When he gets up the crystals have turned to white mush. It turns out that the crystals are lkaite, a mineral of calcium carbonate with 6 waters attached that is only stable at freezing temperatures. It is a well-known mineral to chemists who synthesized it 150 years ago but not to mineralogists. Apparently, these crystals occasionally get encased in mud and mineralized with calcite and called Glendonite.

Ok, this is just mineralogy gibberish, let's get to the payoff.

In opal fields in Australia are found "fossil pineapples" or "opal pineapples". They are fossil casts after the original lkaite gets cemented with calcite becoming Glendonite and then replaced with precious opal. Sometimes these pseudomorphs are incorrectly attributed to glauberite.

There is considerable interest in this because the mineral ikaite is only stable in freezing temperatures. It is nice to see that the clam paleontologists can help out their mineralogist friends, but it would be unwise for me to point it out because I live with one.



#### **DECEMBER BIRTHSTONES**

Birthstones for December are tanzanite, zircon, and turquoise, although it is the blue tints of the latter two that are being promoted by the gem industry.

Tanzanite, a lovely blue-purple stone, can substitute for sapphire, although it is softer, and sometimes not much less expensive. Tanzanite may be the newest gemstone and is found only in Tanzania.

It is a variety of the mineral zoisite, a calcium aluminum hydroxyl sorosilicate, with the chemical formula is (Ca2Al3(SiO4) (Si2O7)O(OH)) + (Cr,Sr), with trace amounts of vanadium accounting for the blue color. It was introduced to the jewelry market by Tiffany's in 1968.

Zircon is an under-appreciated stone that appears in a great variety of colors. It can be a diamond replacement in its colorless form. Zircon and cubic zirconia both contain zirconium, but their chemical formulas and crystal structures are different. The zircon rough that you can buy is natural,

while cubic zirconia sold for faceting is synthetic. Confusingly, zircon can also be manmade and cubic zirconia can exist in a natural form.

Zircon is common in both igneous and metamorphic rocks, and as detrital grains in sandstone. It has a harness of 7.5 and crystallizes in the tetragonal class. Colors are brown, blue, gray and colorless. Heat treatment can turn brown or grey zircon blue. It is a zirconium silicate mineral with the formula (ZrSiO4).

Turquoise, on the other hand, has been known since antiquity. It is important in cultures around the world, notably Amerindian, Mongolian, and Persian. Beautiful turquoise has been mined in Iran (formerly Persia) since antiquity, and it was a popular trade item, beloved for its color and protective qualities. There are many mines in the American Southwest and Navaho and Hopi jewelry have become famous world-wide.

Many books and articles have been written about turquoise, and the name itself is a popular adjective for describing blues of certain shades and tropical seas. The color turquoise is a blue with some green, but the gemstone turquoise comes in shades from almost white through many shades of blue and green, with and without brown or black matrix or spiderwebbing. It is a hydrated phosphate of copper and aluminum, with the chemical formula CuAl<sub>6</sub>(PO<sub>4</sub>)4(OH)8·5H2O. Or you could just call it beautiful!

The December 2018 Chips and Chatter featured an article titled "Tourmaline, a Mineral for Christmas." The Watermelon variety of tourmaline with its red and green needles on a white matrix had all the colors to remind me of Christmas – Green (Christmas Tree), Red (Santa's Suit), and White (Snow).

As a rock for Christmas, I nominated Bloodstone – a green variety of chalcedony or Heliotrope that has red spots of hematite scattered


I was thinking about a new Christmas Rock or Mineral and found a gold mine of ideas on Mindat, an article titled Minerals Reminiscent of Christmas (reference below).

throughout. Again, it was the colors, red and green, that led me to name it my Christmas Rock.

In December 2019 I added the Calcite and Willemite specimens from Franklin County, NJ to my list of Christmas Minerals. When illuminated with an ultraviolet light source (black light), Willemite displays brilliant red and Calcite displays brilliant green areas (islands) on a black background. When illuminated by a normal light source, it often shows green and white areas.







Due to copyright laws, I cannot show you the pictures from the article, but I would highly encourage you to follow the link and take a look for yourself. You will find a decorated Christmas Tree in a Silver specimen, a Stilbite bow tinged with Celadonite, a Christmas scene with a Christmas tree using rocks and minerals as ornaments, rocks and mineral gifts

around the tree, and a fireplace with a glowing (red colored) rock fire.



You will also find a Gold and a Cerussite Christmas wreaths, a blue Christmas tree, a mineral forest with a Christmas tree, a

#### MINECRAFT TEACHES CHILDREN ABOUT MINERALS AND ROCKS

Sort of! The properties ascribed to the building blocks employed in the game Minecraft would amaze most minerologists. But then, it is a game, one both children and adults can enjoy. Families can build "worlds" together (or blow them up). When I played Minecraft, a sandbox game developed by Mojang Studios, with my grandkids during the first summer of lockdown, I often laughed at the mining of diamonds or iron or the use of bedrock or obsidian for building. Something to remember: if you dig into bedrock too far, you can literally fall off the world (and die). Of course, there are many materials the gamer must acquire if selecting the option of building a world from the beginning, starting with shelter from the omnipresent zombies and creating weapons and tools.

Most parents or grandparents can't walk to a display case and pull out a specimen of obsidian and say, "Here is the real rock" and discuss its properties with the young players building worlds. I could do that even if the kids would rather focus on the game. I figured that at least the young gamers were getting used to the idea that it takes resources to build everything they see around them.

#### **CURRENT BYLAWS**

ARTICLE IV: BOARD OF DIRECTORS

Section 2 - Meetings

The Board chooses the time, place, and format (in person or virtual) to meet. Seven Board members constitute a quorum. Meetings may be held at the call of the President or at the request of any Board member.

All business coming before the Board will be decided by a majority vote of the Board members present if there is a quorum. The President will only cast a vote in the event of a tie. Only the Board members have the right to vote at a Board meeting. Proxy voting will not be allowed. Special Meetings and voting via email will be allowed when pressing business decisions are required outside of normally scheduled Board Meetings. Special email meetings and votes will be subject to the same quorum and voting rules as regular Board Meetings.

If we are not able to elect a new 1st VP, Treasurer, and Secretary for 2023, the Board will only have 7 voting members (because Nancy English only votes to break a tie), and if even one person misses a Board meeting no votes can be held. The definition of a Board quorum needs to be updated to avoid possible inability to hold votes for next year. Robert's Rules of Order states that small boards such as ours may allow the President to vote and I think we should change that. Additionally, we need to redefine what constitutes a quorum in a way that avoids ties and is flexible to adjust the number of Board members.

Michele Marsel moved that the HGMS Bylaws be amended as follows:

ARTICLE IV: BOARD OF DIRECTORS

Section 2 - Meetings

The Board chooses the time, place, and format (in person or virtual) to meet. A Quorum is defined as 1/2 the number of voting Board Members rounded up to the nearest odd number to avoid tied votes. Meetings may be held at the call of the President or at the request of any Board member.

All business coming before the Board will be decided by a majority vote of the Board members present if there is a quorum. [REMOVE THE FOLLOWING SENTENCE] The President will only cast a vote in the event of a tie. Only the Board members have the right to vote at a Board meeting. Proxy voting will not be allowed. Special Meetings and voting via email will be allowed when pressing business decisions are required outside of

normally scheduled Board Meetings. Special email meetings and votes will be subject to the same quorum and voting rules as regular Board Meetings.

Example of how the quorum will function:

- If we don't fill the 1st VP and Treasurer positions, then there will be 9 voting Board members including the President. 1/2 that number is 4.5 which would be rounded up to equal a quorum of 5
- If we fill all positions and have 11 voting Board Members, 1/2 that number is 5.5 and that would round up to a quorum of 7 (must be an odd number).

Maggie Manley seconded the motion. By October 18, seven Board members (a quorum) had voted to approve. During this Board meeting, President English asked for a show of hands for the record. 7 For, 1 Opposed, 2 Abstained.

President English presented the approved motion to the General Meeting on October 25, 2022. She explained that the motion had been posted in the Sunday eBlast on October 23, thus beginning the 30-day notice countdown for the membership The motion will be presented to the November 22 General Meeting attendees for a vote.

The next Board of Directors Zoom meeting will be on the first Tuesday, 7:30 p.m., December 6, 2023.

The President thanked Sarah Metsa for her great job on weekly eBlast newsletters this year. She states that she will continue this next year.

Approval of Minutes: Ray Kizer moved to approve the minutes of the October 25, 2022, General Meeting as published in the November BBG. James Eleckel seconded the motion and it passed.

#### COMMITTEE/SECTION REPORTS

Please look for reports of future Section meetings and programs in the BBG calen-dar, on the Website https://hgms.org/events, or by reading the weekly e-blast from Houston Gem and Mineral Society.

Sarah Metza explained that new members are added automatically to the email list as soon as Beverly Mace forwards the membership information to Sarah. Members only need to contact the Publicity Chair at News@hgms.org if they want to be removed from the e-Blast list.

President English invited other Section Chairs and Standing Committee Chairs to make any additional announcements.

Education Committee: Maggie Manley Nancy English reminded the audience that HGMS is offering a Santa's Workshop Day on Sunday, December 4, from 10:00 a.m. to 5:00 p.m. at the HGMS Clubhouse. Participants will leave with projects that are suitable for gifting and information about HGMS and what we have to offer. There are fourteen sessions comprised of seven different projects planned. Costs will range from free to \$50.00. These are short-term, beginner to intermediate-level classes. All of the classes being offered were published in the eBlast. Attendance:

Through the front door: 2557 adults, 407 kids = total 2964. This is 363 less than last year so it is a bit disconcerting that the trend is down. However, we raised our ticket price by \$1 so the revenue stayed about the same.

Kids Day: 933 kids, about 480 adults on Friday. All of these are free, but this meant that a total of over 2000 people visited our show on that day, which was one of the main reasons our dealers were ecstatic about their sales on that day. Plus, we provided a great educational program for the general public, thus satisfy-ing our educational non-profit tax-exempt status.

Scout Geology Merit Badge Program: we had 97 Scouts go through our merit badge program on Saturday. This program takes a lot of effort to put together but is another educational service we provide to the public.

#### Security:

Security: Our security team, led by Rick Rexroad and Sharon Halton and a host of volunteers, successfully caught two shoplifters red-handed. Our onsite Humble PD officers apprehended the suspects and had them return the items before escorting them out the door.

#### Safety:

EMS: we had one health event at the show. One of our youth volunteers fainted at the sight of blood and fell backward causing a possible concussion. The EMS was called to provide first aid and call 911 which resulted in an ambulance and fire truck responding. The youth was taken to the hospital for testing and is OK.

Surrounded by Scott's gorgeous collection of specimens, we heard the statistics that are available and listened to some volunteers' ideas for a better volunteer experience and a better Show. Scott donated petrified wood. Neal brought fossils. Sarah brought Info Booth largesse. Nancy English brought leftover volunteer-shift door prizes. There was plenty for everyone.

First-year volunteers came to meet other rock lovers and propose ideas for future shows.

Michele Marsel will continue to do the bookkeeping and work with President English to field any questions the Board has. Michele will not be attending the meetings NOR take part as a voting member.

Nancy Fischer moved to approve the proposed slate of officers for 2023. Ray Kizer seconded the motion and it passed.

#### Bylaws change:

The BOD passed a motion to change the Bylaws. Because of the pending change in the number of board members the By-Laws need to be changed so club business can continue in January. During the last General Meeting, President English read from the Bylaws (which were distributed in the recent eBlast) and explained that the Board of Directors will not be able to reach a quorum to vote on any business without a change to the current bylaws. After the October Board of Directors meeting, a proposal was made to change the wording of the bylaws that will allow the Board to continue to function. Only the Board members have the right to vote at a Board meeting. Proxy voting will not be allowed. Special Meetings and voting via email will be allowed when pressing business decisions are required outside of normally sched-uled Board Meetings. Special email meetings and votes will be subject to the same quorum and voting rules as regular Board Meetings.

If we are not able to elect a new 1st VP, Treasurer, and Secretary for 2023, the Board will only have seven voting members (because the president only votes to break a tie), and if even one person misses a Board meeting no votes can be held. The definition of a Board quorum needs to be updated to avoid possible inability to hold votes for next year.

Robert's Rules of Order states that small boards such as ours may allow the President to vote and I think we should change that. Additionally, we need to redefine what constitutes a quorum in a way that avoids ties and is flexible to adjust the number of Board members.

Via email Michele Marsel moved that the HGMS Bylaws be amended as follows: ARTICLE IV: BOARD OF DIRECTORS

Section 2 - Meetings

The Board chooses the time, place, and format (in person or virtual) to meet. Seven Board members constitute a quorum. [ CHANGE the preceding sentence to read: A Quorum is defined as one-half the number of voting Board Members rounded up to the nearest odd number to avoid tied votes.] Meetings may be held at the call of the President or at the request of any Board member.

All business coming before the Board will be decided by a majority vote of the Board members present if there is a quorum. [REMOVE THE FOLLOWING SENTENCE] The President will only cast a vote in the event of a tie. Only the Board members have the right to vote at a Board meeting. Proxy voting will not be allowed. Special Meetings and voting via email will be allowed when pressing business decisions are required outside of normally scheduled Board Meetings. Special email meetings and votes will be subject to the same quorum and voting rules as regular Board Meetings.

Example of how the quorum will function:

- If we do not fill the 1st VP and Treasurer positions, then there will be nine voting Board members including the President. Half that number is 4.5 which would be rounded up to equal a quorum of five
- If we fill all positions and have eleven voting Board Members, half of that number is 5.5 and that would round up to a quorum of 7 (must be an odd number).

Discussion followed where concerns were raised about reducing the number of voting members and that the president would be able to vote in conditions other than to break a tie. Tom English asked If the BOD does not have a quorum can they get a consensus of what the board wants so the board can agree to wait for a quorum or abandon an idea that would not be passed with a quorum? President English reminded the audience that postponing decisions is what makes progress take months instead of weeks. That slow progress keeps people from wanting to participate in the Board. Sigrid Stewart was concerned that reducing the required number of people for a quorum would potentially allow decisions for the club to be made by as few as five people.

President English pointed out that if the decision to reduce the quorum is not passed tonight and we do not fill the open officer positions we will not be able to do business in January. She also commented that the way to avoid that is for more people to join the Board. President English suggested that a motion be passed at this meeting and the Board would consider these concerns towards reversing the motion in January.

President English asked for a motion to approve the Bylaws change. Sarah Metsa moved to accept the proposal, Richard Good seconded the motion, 14 people attending approved, 2 approved by zoom, 2 were not in favor and 3 abstained.
